

# Keynote

## Cyber Security & Data Breaches Best Practices



**Jason Ingalls**, founder and CEO of Ingalls Information Security, LLC, is an incident response veteran who has led or contributed to the successful resolution of many of the largest data breaches in history. He has over 20 years' experience in information technology, and over 15 years of experience in cyber security.

Jason's incident response work began in 2007 with work on the Hannaford Brothers Grocers and TJ Maxx breaches. His team's ability to discover how attackers infiltrated the victims' IT infrastructure, and the strategies that he developed and implemented which led to success-

ful remediation of many high-profile breaches have earned him industry respect and praise.

When requested, Jason continues to provide Subject Matter Expert (SME) consulting for high-profile and high-impact breaches, many of which are undisclosed, as a senior advisor to leading law firms that specialize in cyber security and data breach cases.

Jason and his firm have leveraged the experience and knowledge gained from the many cyber security engagements they have been called upon to provide consult-

ing, testing, and proactive monitoring for clients ranging from multi-national non-profits to small legal firms.

He has been featured in multiple news articles in print and video format as a cyber security expert, including the BBC. He has given talks on cyber security at many industry conferences as well as at higher education institutions including George Mason University and as the keynote speaker at the inaugural Cyber-security Summit for the University of California.

Rotarian **Lawrence Brandon** provided some chuckles on Tuesday as he explained that he was a man with three first names and three last names: Larry Lawrence Brandon.

Lawrence was born in Oakland, CA but grew up in Berkeley, CA. He was a Baptist lad but attended a Catholic school. In the 8th grade he was permitted to serve as an altar boy and later the head altar boy. He was convinced that he wanted to be a Catholic priest. However, in later years after he met his wife in San Antonio, he changed his mind.

Lawrence entered the U.S. Air Force in 1985 and was stationed for four years at RAF Mildenhall in the U.K. where he was a security police officer. He then served at Lackland AFB in San Antonio as a student training advisor and ultimately at BAFB as a substance abuse counselor. He left the service in 1995 when he was called to establish Praise Temple where he now serves as Senior Pastor and CEO.



While pursuing his religious studies he spent some time in Rome studying and was there when Pope John Paul II was

elected. When he returned home, his wife Wanda asked him if he'd learned anything while in Italy.

Lawrence told her that he learned he was now bi-lingual. He then threw out some random words that sounded foreign and then ended with the only two Italian words he knew "Prego!" (you're welcome) and "Grazie" (thank you). He doesn't think that Wanda bought the bilingual claim!

Before he left the stage, President Lawrence presented Lawrence with his PHF+5 lapel pin. Lawrence joined our club in 2016 and he is a firm believer in the good works of The Rotary Foundation.

Other information about Lawrence: He is the former chair of the Shreveport Regional Airport Authority, serves on the Louisiana State Ethics Board and is a member of the Step Forward Initiative. He is the managing partner of Brandon Group International and the President of the Northwest Louisiana Community Development. He is enrolled in the Graduate School of Theology pursuing a Doctor of Ministry Degree in Church Ministries and Leadership at Oral Roberts University.
