Joseph Mann

Joseph Mann is the owner and operator of the Homeland Security Group, LLC a private investigation and consulting firm in Shreveport. He is a retired senior agent from the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), after serving 35+ years in federal law enforcement.

Mann's career started in 1977 with the U.S. Air Force, in the security police career field. During his eight years in the Air Force, he was stationed at Malmstrom Air Force Base, Montana, The Pentagon and Barksdale Air Force Base. His most accomplished assignment was security to the Chairmen of the Joint Chiefs of Staff/ The National

Military Command Center, and Defense Secretary Casper Weinberger at the Pentagon in 1983,

After leaving the military in 1985, Agent Mann accepted a position with the Department of Energy as a nuclear materials courier.

In 1988 Mann pursued his lifelong dream with the U.S. Secret Service. He was transferred to the White House where he was responsible for the security of President Ronald Reagan and President George H.W. Bush, Sr. and First Family.

In 1991, Mann transferred to the ATF as a criminal investigator, returning to the Shreveport area. He became a certified explosives specialist, a hazardous materials specialist and a member of ATF's national response team. He assisted in the Unabomber investigation, the hunt for Eric Rudolph, Oklahoma City bombing, the 9/11 Pentagon incident as well as working high profile events such as Salt Lake City Winter Olympics, NFL Super Bowls, Miss USA pageants, U.N. General Assemblies and others.

Mann holds a BS in criminal justice from the College of Great Falls, Montana, a BA in fire science from Western Illinois University and a MA in homeland security from American Military University. He holds a 1990 American Red Cross Life Saving award recognized by President George Bush, Sr. as well as many other honors and awards achieved throughout his career.

Memorial Resolution Lionel Willer Eltis

WHEREAS, on June 3, 2018, Lionel Willer Eltis passed away, having led a fruitful and productive life devoted to his family, country, fellow Rotarians, and friends.

The only child of Ethel and Benjamin Eltis, Lionel Eltis was born at Shreveport, Louisiana, on September 2, 1917. He enrolled at Creswell Elementary School on the very first day it opened its doors. After graduating from C.E. Byrd High School in 1934, he started work at age 17 with Louisiana Paper Company, first unloading boxcars, then working as a truck driver, inventory clerk, and traveling salesman.

Lionel enlisted in the United States Army on December 8, 1941, and served his country honorably for four years during the second World War in North Africa and Italy, attaining the rank of captain. Shortly after the end of the war, Lionel married Shirley Murov, and the couple moved to Tyler, Texas, where he resumed employment with Louisiana Paper Company as the local branch manager, ultimately rising to the level of chairman of the board of the company. Lionel also served as chairman of the National Trade Paper Association. During the many years spent in Tyler, Lionel was engaged in the local community, serving as president of the Lion's Club and of Temple Beth El. He was very active in The Shriners and performed as a trick motorcycle rider in one of its parade units. He achieved his 33rd Mason Degree.

In 1978, Mr. Eltis and his wife returned to Shreveport. After retiring five years later, Mr. Eltis founded The Paper Shack and Party Store, which he remained active in helping manage until his death.

Lionel Eltis became a member of the Rotary Club of Shreveport on March 1, 1979 and was a multi-level Paul Harris fellow. He was a member of the B'nai Zion Congregation and, at the time of his death, was the oldest member of the Shreveport Jewish community.

Mr. Eltis was predeceased by his loving wife of 68 years, Shirley Murov Eltis. He is survived by his daughter, Sandra Eltis Weiss, and her husband, Mel; by his son, Brian Murov Eltis, and wife Cindy; by grandchildren Daniel Weiss, Michael Weiss, Ashley Grossfeld, Blake Eltis, Lindsay Hochschuler, and Drew Eltis, and their spouses; by his sister-in-law, Mrs. Harold Murov; and by numerous great-grandchildren.

AND NOW, WHEREAS, his fellow Rotarians wish to express appreciation for the fellowship, generosity, leadership, and example of Lionel Willer Eltis; for the time and talent he devoted to the welfare of his fellow man; and for his unflagging belief in all that Rotary stands for, its high ethical standards, and the good that Rotary does in local communities and around the world;

BE IT RESOLVED by the Rotary Club of Shreveport, in regular meeting assembled, that this club express its profound sorrow over the loss of a valued and respected Rotarian and a beloved friend, leader, mentor, and centenarian;

BE IT FURTHER RESOLVED that we extend our deepest sympathy to the surviving members of his family;

BE IT FINALLY RESOLVED that this resolution be made patent upon the permanent records of the Rotary Club of Shreveport and that a copy hereof be delivered to his family.


