This is something you've asked for and here it is!

In 1963 there was a historical event at the Little Union Baptist Church which influenced Dr. Martin Luther King's civil rights movement.

Rev. Dr. Harry Blake was our area's NAACP president at the time and is the only man still alive who played a vital role in the moment. Dr. Blake, a graduate of Bishop College, has been pastor of the Mount Canaan Baptist Church for more than 42 years. He is president of the Louisiana Missionary Baptist State Convention and General Secretary of the National Baptist Convention, USA, Inc. He serves on several local boards and has been a guest lecturer at several theological seminaries and schools around the country.

Rev. Asriel McLain is the son of C.E. McLain, former Little Union pastor. Rev. McLain was ten years old at the time of the incident and recalls being scared at the time. He is a graduate of Ruston High School's first integrated senior class. The words on the historical state marker seen in front of Little Union Baptist Church, 1846 Milam St. were written by Rev. McLain. He serves as a member-at-large on the Home Mission Board for the National Baptist Convention USA, Inc.
