Keynote Making Louisiana a Better Place For Birds



Erik Johnson

Dr. Erik Johnson joined the Audubon Society in 2011. His first responsibility there was as a conservation biologist for the Mississippi Flyway and Gulf Coast Initiative. He serves now as their Director of Bird Conservation.

Johnson received his B.S. degree in biology and environmental studies from Dickinson College in Carlisle, PA. He then returned to Louisiana to attend LSU and earned his Ph.D. in wildlife, fish and wildlands science and management. He was working on his graduate studies when the BP oil spill shocked the Gulf Coast and, in response, Erik helped develop a citizen science program which he continues to lead.

Dr. Johnson led the development of a comprehensive beach-nesting bird steward-ship program in Louisiana by developing partnerships with other organizations and local communities. He developed several bird monitoring initiatives at the Paul J. Raney Audubon Sanctuary.

Johnson is active in Louisiana's birding community and serves as Louisiana's Christmas Bird Count regional editor, vice-president of Baton Rouge Audubon Society, a member of Louisiana's Bird Records Committee, co-director of the Louisiana Bird Observatory, and most recently joined the Inland Bird Banding Association's board of advisors. He has published several articles that have published in scientific journals including *The Auk* and *Ecology*.

Erik is a resident of Lafayette, Louisiana.


best they can.
