Laura-Ashley Overdyke is the Executive Director of the Caddo Lake Institute with locations in both East Texas and in Shreveport.

Laura-Ashley spent much of her childhood frequenting Caddo Lake; fishing, boating and communing with family and friends. She graduated from Loyola College Prep and went on to Washington & Lee University in Virginia. Upon graduating from W&L, Laura-Ashley joned the National Geographic Society in Washington and was a key member during the launch of the Geographic's first nightly TV news program, managing the research team, producing, and reporting on-air.

She then traveled the country, speaking on behalf of the White House Drug Prevention effort. When Overdyke returned to the Shreveport area, she was named Senior Editorial Producer at local news station KTBS, while revitalizing KTBS investigative and in-depth reporting

along with managing 16 reporters.

Directly before joining Caddo Lake Institute, Laura-Ashley spent two years with the Community Foundation of North Louisiana overseeing donor advised competitive grants.

The Caddo Lake Institute has a 25-year track record of strong science—working with local officials, government agencies and for the community. With her vast experience and pure heart for Caddo Lake, Overdyke will certainly build upon the conservative efforts by exploring unique opportunities that benefit the integrity of the region.

### President Rich's Second Message On Meals/Dues/State of the Club

Dear Rotarian,

My previous message expressed options for individual Rotarians to choose how they would like their funds for missed meals allocated.

Members who pay full dues of \$1,200 per year will have paid \$20 per missed meals (does not apply to Rule of 85 members who opt to omit meals). Exact amount will depend on when we can physically meet again. Adjustments will be on the June statement for the July to December dues cycle.

Your Board has met to discuss this issue and decided the following two options will be offered to those members paying full dues.

1. Apply these funds to the Rotary Club of Shreveport Foundation (this is tax deductible and is used to supplement civic grants and other projects as needed). Your statement will reflect the full dues amount. When you pay your dues all the meals fees missed will be diverted to our Club's Foundation. At the end of the year you will receive a donation statement for your tax return.

No action is required. We will automatically transfer the funds from your dues payment.

2. Request a credit and your dues will be reduced by the final meals affected (Y meals missed x \$20). We understand that these are trying times for families and businesses alike. As such, we are able to issue you a credit for meal fees for all the Club meetings that are cancelled. If you want a credit I ask that you make that request by 31 May.
