Scott Crichton is Associate Justice of the Supreme Court of Louisiana, having qualified without opposition in 2014. His ten year term began January 1, 2015.

Prior to his election to the Supreme Court, Scott served 24 years as a judge with the First Judicial District Court, presiding over 25,000 cases in both the civil and criminal divisions.

Scott is a past president of the Louisiana District Judges Association, a past member of the Advisory Committee to the Supreme Court on Revision of the Judicial Canons, the Louisiana Judicial College Board of Governors, the Court Rules Committee and the Criminal Best Practices Committee.

Since 2007, Justice Crichton has presented a PowerPoint teen consequences program, Don't Let This Be You, to more

than 20,000 teenagers/parents at various high schools, churches and community groups as well as another program, *Sexting, Texting and Beyond*, for teenagers, parents and teachers on electronic laws and related misbehavior.

Justice Crichton received a B.S. degree from LSU and a J.D. degree from Paul M. Hebert LSU Law Center. During the 1980s, he served as an assistant district attorney for Caddo

Parish, maintained a civil practice, and served as an adjunct instructor of Business Law at LSU-S.



Scott and his wife Susie now live in Webster Parish and have two adult sons—both of whom are attorneys.


